# COVERAGE OF HUMAN TRAFFICKING

- Coverage of Human Trafficking is Special Coverage that requires large amounts of energy and funds
- Journalists must be prepared to face enormous risks.
- The protection of press freedom and the safety of journalists is very important

# POSITION OF INDONESIAN MEDIA

- The media pays special attention to the issue of human trafficking by covering and publishing cases of human trafficking that occur.
- In big cases, the media will form a team of journalists, then carry out investigative coverage of the trafficking case

# How To Lobby And Advocate For Human Trafficking Issues ?

- When I receive information about a case of human trafficking, I usually immediately call the police, officials at the ministry of women's empowerment and child protection, the ministry of foreign affairs, and civil society organizations that handle human trafficking cases.
- If they haven't received the information, I will share the information.
- But if they already know, I will ask for confirmation what steps will be taken.
- For example, the police, has an investigation been carried out, have the victims been helped, have the suspects and the trafficking network been handled by the police?
- so I will ensure that all confirmations required by the media are answered by the responsible parties.

# MY EXPERIENCE AS A JOURNALIST

- In certain conditions and emergency situations when victims need immediate assistance, I will contact ministers directly, for example the Minister of Foreign Affairs, the Minister of Women's Empowerment and Child Protection, and high-ranking officials in the police.
- If that doesn't work, I usually contact a member of the House of Representatives. Usually when people's representatives contact the police, the police will act quickly.



# WHAT IS THE IMPACT OF MEDIA REPORTING?

Media news, such as the daily Kompas, will immediately receive the attention of law enforcement and government agencies, as well as the public.
